Principal's Message

Monache High School, part of the Porterville Unified School District, is working hard to help all students achieve high academic standards. There was a time when only a few students were expected to perform at high levels, while others could learn more basic and vocational-type skills in school. The Public Schools Accountability Act of 1999, as well as the No Child Left Behind act of 2002, now requires that all students in public school be held to the same high academic standards. Today's world of work and our new technology/ information-based economy require more complex skills in order to enter the workplace successfully. Each of our students follows a course of study to prepare them to meet the expectations of passing the California High School Exit Exam, which is required in order to obtain a California High School Diploma.

Personal and social growth are encouraged through a variety of programs that appeal to our diverse student body such as athletics, academic competitions, fine and performing arts, vocational courses/organizations, as well as access to a number of community affiliations. Finally, each student and their family are provided opportunities to meet with counselors upon entry into high school to plan a four year program. This four-year plan outlines a course of study to prepare each student with a number of post secondary options and is reviewed each school year.

Community & School Profile

Porterville, lying along the foothills of the Sierras, is located on State Highway 65, 165 miles north of Los Angeles, and 171 miles east of the Pacific Coast. Centrally located to major markets, the city has strategic access to major transportation routes. Porterville Unified School District serves more than 13,000 students throughout the community, as well as the town of Strathmore. The district is comprised of ten elementary schools, three middle schools, four comprehensive high schools, one magnet academy, one continuation high school, and two alternative sites.

Monache High School, located in the southeast corner of Tulare County, serves students in grades nine through twelve on a traditional calendar schedule. Curriculum is based on meeting state standards, college readiness, and career technical education. Diverse literature selections, annual multicultural week, student body clubs, and various activities sponsored by the Associated Student Body (ASB) promote a climate of tolerance and acceptance among students and faculty. During the 2012-13 school year, 1,852 students were enrolled at the school. Student demographics are displayed in the chart.

Opportunities for Parental Involvement

Parents and the community are very supportive of the educational programs in the Porterville Unified School District. Parent Booster Clubs play an active role in the community and at each school site through fundraising and special activities. Contributions by the many community partners such as, Wal-Mart, Target, and Eagle Mountain Gaming Casino, add to the programs available at Monache High School.

School Safety Plan

This section provides information about the school's comprehensive safety plan, including the dates on which the safety plan was last reviewed, updated, and discussed with faculty; as well as a brief description of the key elements of the plan.

The safety of students and staff is a primary concern of Monache High School. Teachers, campus supervisors, and administrators supervise and monitor students on campus before and after school, and during the brunch and lunch breaks. In addition, police officers lend their support on a daily (as needed) basis and probation officers lend their support twice a week. All visitors must sign in at the principal's office and receive proper authorization to be on campus. Visitors are asked by the staff to display their pass at all times.

The School Site Safety Plan was most recently revised in fall 2012 by the Safety Committee. Key elements of the plan focus on emergency preparedness. The school is in compliance with the laws, rules, and regulations pertaining to hazardous materials and state earthquake standards. Emergency drills are held on a regular basis; fire drills are held once a semester, earthquake drills are held twice a year, and secure campus drills are conducted once each year.

Monache High School was originally constructed in 1967 and has since undergone complete modernization. The most recent renovations to the campus occurred in 1999-2000, and included the installation of a new security system and HVAC units, new wiring to all existing structures, gutting and renovation of several classrooms, and new roofing on all buildings. The campus is currently comprised of 83 classrooms (including portables), a library/media center, a multimedia/technology center, three computer labs, two staff rooms, a cafeteria, five athletic fields, two gymnasiums, and the main office. The chart displays the results of the most recent school facilities inspection, provided by the district in September 2013.

Cleaning Process

The school provides a safe and clean environment for students, staff, and volunteers. The district governing board has adopted cleaning standards for all schools in the district. Basic cleaning operations are performed on a daily basis throughout the school year with emphasis on classrooms and restrooms. A joint effort between students and staff helps keep the campus clean and litter-free. The principal works daily with the custodial staff to develop sanitation schedules that ensure a clean, safe, and functional learning environment.

Maintenance & Repair

A scheduled maintenance program is administered by the school's custodial staff on a regular basis, with heavy maintenance functions occurring during vacation periods. Additionally, a scheduled maintenance program is administered by the district to ensure that school grounds and facilities remain in excellent repair. A work order process is used when issues arise that require immediate attention. Emergency repairs are given the highest priority; repair requests are completed efficiently and in the order in which they are received. At the time of publication, 100% of the school's restrooms were in working order.

Professional Development

A constructive evaluation process promotes quality instruction and is a fundamental element in a sound educational program. Evaluations and formal observations are designed to encourage common goals and to comply with the state's evaluation criteria and district policies. Temporary and probationary teachers are evaluated annually and tenured teachers are evaluated every other year.

Evaluations are conducted by site administrators, who have been trained and certified for competency to perform teacher evaluations. Evaluation criteria includes the following:

- Engaging and Supporting all Students in Learning
- Understanding and Organizing Subject Matter for Student Learning
- Assessing Student Learning
- Creating and Maintaining Effective Environments for Student Learning
- Planning Instruction and Designing Learning Experiences for all Students
- Developing as a Professional Educator

Staff members build teaching skills and concepts through participation in conferences and workshops throughout the year. The district offers two full day and two half day staff development days.

During this time, teachers are offered a broad-based variety of professional growth opportunities in curriculum, teaching strategies, and methodologies. The school uses the Best Practices teaching strategies and teachers are trained in the techniques each year.

For additional support in their profession, teachers may enlist the services of the district's Beginning Teacher Support and Assessment (BTSA) facilitator and/or the Peer Assistance and Review (PAR) program.

- **California Standards Tests (CSTs)**, which include English-language arts (ELA) and mathematics (Math) in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science (H-SS) in grades eight, and nine through eleven.
- **California Modified Assessment (CMA)**, an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- **California Alternate Performance Assessment (CAPA)**, includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

DataQuest is an online data tool located on the CDE DataQuest webpage at dq.cde.ca.gov/dataquest/ that contains additional information about this school and comparisons of the school to the district, the county, and the state. Specifically, DataQuest is a dynamic system that provides reports for accountability (e.g., state Academic Performance Index [API], federal Adequate Yearly Progress [AYP]), test data, enrollment, high school graduates, dropouts, course enrollments, staffing, and data regarding English learners.

Admission requirements for the University of California (UC) follow guidelines set forth in the Master Plan, which requires that the top one-eighth of the state's high school graduates, as well as those transfer students who have successfully completed specified college course work, be eligible for admission to the UC. These requirements are designed to ensure that all eligible students are adequately prepared for University-level work.

Eligibility for admission to the California State University (CSU) is determined by three factors:

- Specific high school courses
- Grades in specified courses and test scores
- Graduation from high school

Some campuses have higher standards for particular majors or students who live outside the local campus area. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. Monache High School offers a Manufacturing and Construction Technology Academy for students in grades ten through twelve, in addition to the existing Multimedia Technology California Partnership Academy.

The Academies have openings for students with career interests in the respective academy fields of study, offering concentrated curriculum in addition to core academic subject areas.

Tulare County Occupational and Vocational Education (TCOVE) classes are also available. The Work Experience program allows students to earn credit for working and attending classes that teach specific information about the world of work.

The Trades and Industry Department (TID) has made an agreement for a 2+2 program with Porterville College and the College of the Sequoias. With College of the Sequoias, TID offers a program in construction, welding, and drafting. With Porterville College, TID offers a program in building trades, cabinet making, computer-assisted drafting, and engineering drawing.

The Grow in Vocational Experience (GIVE) Program offers students a variety of career experiences at Porterville Developmental Center.
